Declaration of conformity for authorisation to use for special articles the mark “OEKO-TEX® STANDARD 100 - Special Articles”.

This document can be issued in various languages. If there are any differences in the interpretation of this document due to language reasons, the English version shall take precedence.

The authority for using the mark "OEKO-TEX® STANDARD 100 - Special Articles“ is restricted to the applicant. Use of the mark presupposes a test report from a testing institute certifying the authorisation as well as issue of the following declaration.

Declaration

For authorisation to use the mark "OEKO-TEX® STANDARD 100 - Special Articles“ I declare as authorized person on behalf of my company.

1. Quality control

We have described to one of the testing institutes the precautionary measures taken within the company to ensure that all products manufactured and/or sold for which authorisation to use the mark "OEKO-TEX® STANDARD 100 - Special Articles" has been granted do fulfil the conditions and criteria of the OEKO-TEX® STANDARD 100 – Supplement Special Articles in the same way as the samples that have been sent to the institute, and based on those tests the authorisation has been granted to use the OEKO-TEX® STANDARD 100 – Supplement Special Article mark. At this we consider certainly to which requirements our products – based on our application – were tested and certified (depending on application either according to conditions/criteria Annex 4 or according to conditions/criteria Annex 6 of the OEKO-TEX® STANDARD 100; possibly also under consideration of the co-applicable OEKO-TEX® LEATHER STANDARD).

2. Quality assurance

To ensure the conformity of the products manufactured with the sample material and/or sold we operate an effective quality assurance system and shall maintain it for the whole period of use of the mark "OEKO-TEX® STANDARD 100 - Special Articles", thereby ensuring and proving to the OEKO-TEX® institute that the products from different processing batches or from different colours are spot-checked for compliance with the conditions and criteria of the OEKO-TEX® STANDARD 100 – Supplement Special Articles. At this we consider again, to which requirements our products – based on our application – were tested and certified (depending on application either according to conditions/criteria Annex 4 or according to conditions/criteria Annex 6 of the OEKO-TEX® STANDARD 100; possibly also under consideration of the co-applicable OEKO-TEX® LEATHER STANDARD). Tests can be carried out at our works or at one of the OEKO-TEX® institutes.

We document these tests by specifying:

- Date of testing
- Designation of the test sample (manufacturing batch, finishing batch, colour, etc.)
- Person responsible for the test
- Test result
- Random tests

Moreover we accept that the institute granting authorisation for use of the mark "OEKO-TEX® STANDARD 100 - Special Articles" is authorized to carry out random tests on each product under application in accordance with the original type twice a year until we indicate to the institute of OEKO-TEX® that production and/or sale has been discontinued and the mark "OEKO-TEX® STANDARD 100 - Special Articles" is no longer used. The costs of testing are charged to us. If random testing reveals a deviation from the limit values on which the tests are based, an additional test shall be carried out on a different sample for the purpose of checking, and the relevant costs are likewise charged to us. If further deviations are found, the OEKO-TEX® institute responsible for the granting of the authorisation may withdraw the authorisation to mark the product with the label "OEKO-TEX® STANDARD 100 - Special Articles" with immediate effect. The use of existing advertising materials, displays, labels, etc. is limited to two months from the time of withdrawal.

However, in cases where at the control tests a severely/serious deviation from the underlying/required limit values is found, the testing institute and as the circumstances require also the OEKO-TEX® Secretariat has also the right, to withdraw the issued certificate and the authorisation to label the products with the OEKO-TEX® STANDARD 100 – Supplement Special Articles mark with immediate effect. In such cases it is also possible to prohibit the use of advertising materials, display labels, labels, etc. with immediate effect.

We acknowledge, that auditors from the testing institute are allowed to visit and audit the company in reference to the certification process according to OEKO-TEX® STANDARD 100 – Supplement Special Articles. In case of non-compliance with the requirements and criteria the cost for the analytical testing (control tests) and an audit fee have to be paid by us.

We acknowledge that the certifying institute or an OEKO-TEX® Auditor is entitled to check our company with reference to the quality assurance measures in respect of the certification process according to OEKO-TEX® STANDARD 100 –



Supplement Special Articles. This control will take place, under normal circumstances, in a three year cycle; the first time before or shortly after issuing the first certificate to our company. The costs of these visits are charged to us. Companies already certified according to OEKO-TEX® STeP are exempt from these additional audits and payments.

3. Limit of authorisation

We know that the authorisation to label a product with the mark "OEKO-TEX® STANDARD 100 - Special Articles " is limited to a maximum of one year.

4. Conformity declaration

We, the producer and/or distributor of a product labelled with the mark "OEKO-TEX® STANDARD 100 - Special Articles" declare on our own responsibility, that the product manufactured and/or sold complies with the conditions and criteria of the OEKO-TEX® STANDARD 100 - Supplement Special Articles, which we herewith accept. The limit values and criteria of the harmful substances of the underlying OEKO-TEX® STANDARD 100 and those of the possibly also co-applicable OEKO-TEX® LEATHER STANDARD are well known to us and are accepted. We are fully responsible for quality assurance of the certified product. We may delegate parts of the quality assurance to producers, suppliers and importers. In the case of delegation we fully has to acquaint the certifying body with the effectiveness of the relevant quality assurance system.
